5 YEAR INTEGRATED PROGRAMME IN MANAGEMENT



Indian Institute of Management Rohtak is the IIM established by the Ministry of Education, Government of India by IIM Act 2017. IIM Rohtak is an institute of national importance as per the Ministry of HRD, Government of India.

Established in 2009, the Indian Institute of Management Rohtak is a benchmark for top management education in India with a vision to become a global leader in due course. The institute has an enlightened and progressive leadership, acclaimed faculty members, extensive infrastructure, and robust teaching pedagogy in place. Located within the National Capital Region (NCR) of India, IIM Rohtak is 90 minutes from Delhi international airport. The state-of-the-art campus spread over an area of 200 acres, is strategically located on National Highway - 10, and is well connected to Delhi. IIM Rohtak has been ranked 8th in the country on educational ranking. Institute offers a dynamic environment for high-quality research in all functional areas of management that will benefit various segments of the business and society.



Five-Year Integrated Programme in Management (IPM) is for students after class XII who aim to pursue their career in Business Management. It is a comprehensive management program that has a combined course of management studies from undergraduate (UG) to postgraduate (PG). Programme aims at molding outstanding young students into managers and leaders. Upon successfully completing academic rigor of 5 years, the participant will be awarded Master of Business Administration (MBA) by IIM Rohtak. There is no automatic entry into the fourth and fifth years. The students will have to maintain a minimum CGPA of 5 to be eligible for the last two years of the program to earn a master's degree. Students below that CGPA will be awarded a BBA degree and will exit the program. Also, if any student voluntarily intends to exit the program after successfully completing the programme requirement at the end of 3 years, he/she will be awarded a degree of Bachelor of Business Administration (BBA).

#### Programme Structure

Overall, the programme consists of 15 terms spread over a period of 5 years. A year has three terms, each of 3 months duration. The entire programme is divided into two parts; the first part focuses on the foundation courses, whereas the second part focuses on management. Students will be undergoing internships at the end of every academic year.

## CURRICULUM

The curriculum has four core areas: Mathematics, Economics, Statistics, and Humanities. Apart from these, other courses such as Business Communication, Management Information System, Business, and Foreign Languages are also offered. Courses offered at the PG level (4th and 5th Year) will be the same as the PGP curriculum.

\*In addition to the academic courses, students get an opportunity to undertake a variety of co-curricular and extra-curricular activities, which enables them to pursue their interests and sharpen their management skills.

Every year, the student will undergo various projects, which include immersive learning opportunities in the form of research work with the faculty of IIM Rohtak, a rural/ social emersion project, and a business internship. Placement support will be provided to the students completing five years of course of studies.



Candidates must satisfy the following criteria to apply for this programme:

**ADMISSION CRITERIA** 

- General, NC-OBC and EWS Category: Minimum 60% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as of June 30, 2022
- SC, ST and PWD (DAP) Category: Minimum 55% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as of June 30, 2022.

\*<u>Note 1</u>: Candidates who are likely to complete standard XII/ HSC or equivalent by the end of June 2022 can also apply, subject to meeting the minimum eligibility criteria after the declaration of results (only in case of XIIth standard) as mentioned above. If selected, such candidates will be offered admission to the programme provisionally. At the time of registration for the programme, such candidates must produce X and XII standard mark sheets (securing minimum marks i.e., 60% for General, EWS, and NC-OBC or 55% for SC, ST, and PWD) along with school-leaving certificate/migration certificate, failing which the candidate's admission offer stands cancelled.

\*\*<u>Note 2</u>: The percentage of marks obtained by the candidate in X and XII Standard would be calculated based on the aggregate marks of the best five subjects that appear in the mark sheet/grade sheet, irrespective of the Board's regulation. In case the candidates are awarded letter grades or grade points instead of marks, the conversion of grades to the percentage of marks of best five subjects would be based on the procedure certified by the Board/ Competent Authority explaining the method of conversion from where they have obtained the certificate.



Stage 1: Online Registration

(i) Interested applicants who fulfill the above-mentioned eligibility criteria will fill the registration form that aims at evaluating the applicant's proficiency in academics as well as in extra-curricular activities.

(ii) The eligible applicants will pay a non-refundable registration fee of Rs. 3890/- (Three Eight Hundred and Ninety Only)

(i) All the interested applicants will undergo IIM Rohtak's IPM Aptitude Test that will examine the aptitude, logical reasoning, and proficiency in English of the applicant.

(ii) IPM AT 2022 to be conducted on June 26, 2022 from 2 PM to 4 PM.

(iii) IPM Aptitude Test will comprise of following sections:

Section	Number of Questions	Time Duration for Each Section
Quantitative Ability	40	40 minutes
Logical Reasoning	40	40 minutes
Verbal Ability	40	40 minutes

\*Note: Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

Stage 3: Online Personal Interview (PI)

(i) The announcement of the Call for Online Personal Interviews (PI) will be done in the First Week of July 2022 (Tentative). The shortlisting will be based on the IPM AT 2022 scores.

(ii) The candidates during their personal interviews will be judged on the basis of their academics, general awareness, and communication skills.

(iii) The interviews are proposed to be held in the Second Week of July 2022 (Tentative).

Stage 4: Announcement of Selection List and Offer Acceptance

(i) The final Merit List will be generated based on the composite score as mentioned below:

Component	Weightage (%)
Aptitude Test Score	45
Personal Interview	15
Past Academics (10th and 12th)	40 (20% each)

(ii) The announcement of Merit/Rank List and sending of Offer Letters to the selected candidates will be done by the Third Week of July 2022. The candidates receiving the offer letter for IIM Rohtak IPM Admission 2022 and accepting the offer within the stipulated date will require to deposit the Offer Acceptance Amount (as mentioned in the offer letter) through an online payment link.

#### Stage 5: Provisional Admission to IPM 4 (2022-27)

(i) The candidates accepting the offer of admission to IPM 04 (2022-27) will be given a confirmation letter. The candidate is required to pay the First Year Programme Fee (as mentioned in the confirmation letter) and needs to report to the institute campus for registration on the stipulated date. If the COVID situation prevails, the registration will be done online.

(ii) If the candidate registers for the programme in the stipulated date, his/her OAA will be adjusted with the First Year Programme Fee.

(iii) Further, on the day of reporting to the campus for registration, the admission team will do physical verification of the documents. In the case of online registration, the documents will be verified virtually. (iv)Withdrawal of OAA: In case a candidate withdraws after paying the Offer Acceptance Amount but before paying the first-year programme fee, the OAA will be refunded after deducting processing charges of Rs. 20,000/-

(v) Withdrawal of Provisional Admission: In case a candidate withdraws before the in-campus/ online registration but after paying the first-year programme fee, the first-year programme fee will be refunded after deducting processing charges as per the norms.

(vi) Last Date for any withdrawal of provisional admission will be 'On or before the date of Registration' (online/ on-campus as the case may be). No refund of any fee will be permissible after the date of registration.

(vii) The academic session will begin in the August 2022. The allocation of the hostel room to the candidate will be done on sharing basis. Hostel rooms for the DAP category will be arranged on the ground floor. All academic sessions may continue online if the COVID situation prevails.

#### Notes

(i) The admission criteria for IPM 2022-27 may be changed before the declaration of the results.

(ii) The information in this document is applicable only for the admissions cycle IPM 2022. IIM Rohtak reserves the right to change, modify or adopt any new admission process that it deems necessary at any point.

(iii) Any dispute concerning Admission for the IPM Batch 2022-27 would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Rohtak only.

(iv) You will receive all admission offers in the form of a letter duly signed by the admission chair of IIM Rohtak sent from ipmadmission@iimrohtak.ac.in. Any offer received from any other email is completely invalid and is not official. All admissions to IIM Rohtak are provisional till you have completed all formality upon reporting to the institute.

(v) IIM Rohtak reserves the right to change, modify or adopt any new admissions process that it deems necessary at any point.

#### REGISTRATION FOR IPM PROGRAMME

Final shortlisted candidates who have deposited Offer Acceptance Amount and got confirmation letter for provisional admission, will be required to report in the campus for registration process followed by physical verification of educational document and other testimonials as per checklist. In case of prevailing COVID situation, registration and academic sessions will be conducted online.
